Note 1: 28-4135A, B, C

- If you provide proof showing the vehicle involved was insured on the DATE and TIME the complaint was issued, the charges will be dismissed.
- If you obtain a six month liability insurance policy after being cited, contact the court on or before your appearance date.

Note 2: 28-645A3A

If you have been cited for this violation for a first offense, you may be eligible to attend a defensive driving class and have the violation dismissed. If you choose to go to trial (plea of not responsible) then you are not eligible to attend a defensive driving school. If you are found responsible for the violation, you will be assigned by the Motor Vehicle Division (MVD) to attend a Traffic Survival School class when MVD receives notice of the violation.

Note 3: Any person who had a CDL (Commercial Driver's License) License at the time of their violation, or who has obtained a CDL License since the date of their violation is NOT eligible to have their citation dismissed through Defensive Driving School.

You have received a civil traffic citation, review the information in this brochure.

Option #1 - Defensive Driving Program

Option #2 - Plead 'responsible' and pay your fine by mail or by telephone.

Option #3 - Plead 'not responsible' and request a hearing by mail.

If you fail to appear, make partial payment or fail to pay a Civil Traffic Sanction 30 days after court date:

- Late payment fee of \$20.00 will be assessed and a default judgment will be entered against you.
- If default judgment is entered, there is an additional \$25.00 court fee.
- Failure to appear will result in forfeiture of your Bond, additional monetary penalties and driver's license suspension.
- Your driver's license may remain suspended until the Civil Sanction is paid to the Court and you have your license reinstated by MVD.
- You may be arrested and incarcerated for driving on a suspended license.

If you have received a criminal traffic citation, you must appear in court on the date noted on your citation.

If you appear in person, appropriate dress is required. No weapons allowed in building. Allow for extra time as you will be required to pass through a security screening device upon entry.

If you have any questions or need additional information, call the Court. Have your copy of the Arizona Traffic Ticket and Complaint available when you call.

Option #1

DEFENSIVE DRIVING SCHOOL

No court appearance is required if you attend a defensive driving diversion course. When you contact the school to schedule a class have your copy of the citation and a pen or pencil with you. You will need to write down instructions for the class. On the day of class you must bring a copy of your traffic citation, your driver's license and a certified cashier's check or money order made payable to the defensive driving program you have selected. CASH or personal checks will not be accepted.

YOU MAY BE ELIGIBLE IF:

1. You were cited for any moving civil traffic violation.
2. You have not attended a Defensive Driving Diversion Class in Arizona in the past two years for a prior Arizona violation dated within the immediate 24 months preceding the current violation date.
3. The violation code on your citation is listed as eligible on the Fine/Sanction Schedule.

IF YOU ARE ELIGIBLE TO ATTEND A DEFENSIVE DRIVING COURSE FOR DIVERSION, YOU MAY ATTEND ONLY A SUPREME COURT CERTIFIED SCHOOL FOR FURTHER INFORMATION CALL:

Course shall be completed at least seven days prior to the court arraignment date. (An extension of time may be granted for up to 30 days to complete the course - contact the court for an extension.)

IMPORTANT:

- IF YOU WERE CITED FOR MORE THAN ONE VIOLATION, YOU CAN GO TO SCHOOL FOR ONLY ONE OF THE ELIGIBLE VIOLATIONS.
- FOR THE OTHER TRAFFIC VIOLATIONS, YOU MUST PAY THE BOND AMOUNT, APPEAR IN COURT OR REQUEST A HEARING.
- IF YOU ATTEND A DEFENSIVE DRIVING PROGRAM, YOU CANNOT CHOOSE OPTION 2 OR 3 FOR THAT VIOLATION.
- IF YOU ARE NOT A RESIDENT OF ARIZONA AND WANT TO GO TO A DEFENSIVE DRIVING PROGRAM IN YOUR STATE CONTACT A SUPREME COURT CERTIFIED SCHOOL .

I understand that I may voluntarily enclose a bond (cashier's check or money order) equal to the fine/sanction, which will be forfeited should I fail to appear for my hearing/trial. I further understand that the bond forfeiture will relieve me of the possibility of the court assessing additional monetary sanctions, issuing a suspension of my driver's license, or a warrant for my arrest should I fail to appear for trial/hearing."
