Approved 1. ~~Z2009-003~~: This is a request by the City of Yuma, on behalf of Klaudia Jan Goldsboro, to rezone approximately .39 acres from the Transitional (TR) District to the Limited Commercial (B-1) District for property located at 2345 South Avenue A, Yuma, AZ.
