On February 6, 2013 former Mayor Alan L. Krieger filed a lawsuit against the City of Yuma, et al. In that lawsuit, former Mayor Alan L. Krieger sought reimbursement of fees and costs he claimed he incurred as a result of an investigation and the lawsuit, among other fees and costs.
