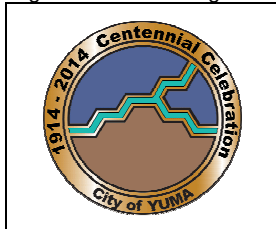


## Notice of Public Meeting of the Design and Historic Review Commission of the City of Yuma
