Deadlines:

Pick up Bat from Yuma Art Center **May 16 - June 15, 2017**. *Bats are available on a first come first serve basis with a limit of one bat per person. Artists may also provide their own bat.
Drop Bat off at Yuma Art Center **August 1-11, 2017**.
Display at Yuma Art Center **August 15-30, 2017**.
Auctioned **September 1 & 2, 2017**, at the Grand Opening of the PAAC.

Terms and Conditions:

1. All works of art must be the Exhibitor’s own original ideas and assembly. All artwork must be original or printed of the exhibitor’s original work. Manufactured or commercially produced works are not permitted. All items to be sold at booth must be indicated on application. The City of Yuma will not be held responsible for any type of copyright infringement.
2. Labeling: Exhibitor must label each individual Work with the Exhibitor’s name and the title of the Work.
3. Subject Matter: The Yuma Art Center may refuse any Work due to the subject matter or condition of the Work. The Yuma Art Center will not accept Work containing nudity or profanity.
4. Marketing and Promotions: By exhibiting Work with the City of Yuma, Exhibitor agrees to have Exhibitor’s name and photographs of the Work(s) reproduced for publicity, promotional and educational uses
