Sculpture Walk Call to Artists Pacific Avenue Athletic Complex

Application Deadline: Ongoing. First review date is January 5, 2018.

Installation Timeline: March to June, 2018.

Artwork Budget: \$750 to \$1,000

Eligibility: All national and international artists and are 18 years of age or older are eligible to apply.

Description: The City of Yuma's Ad Hoc Public Art Committee is seeking to purchase multiple sculptures for a permanent sculpture walk at the Pacific Avenue Athletic Complex (PAAC). This new facility is a state-of-the-art softball complex with six fields and is used for local, regional, and national softball tournaments. Since opening on September 1st, 2017 the complex has had over 50,000 visitors.

Criteria for selection:

1. All media are welcome to submit a proposal. The preferred artwork will be sculptural in nature and be able to be viewed on all sides.
2. Artwork must be a minimum of one cubic yard in size.
3. The proposed artwork can currently exist in the applicant's inventory or the applicant may submit a detailed rendering for new work.
4. Artwork proposed must include professional presentation complete with weather protection and a base as necessary.
5. Artwork will be displayed long-term in high-heat desert temperatures and therefore must be durable and weather resistant.
6. Artwork will be displayed in a high pedestrian trafficked area and must NOT feature any safety or accessibility concerns.
7. Artwork must be of original idea and assembly.

Selection Process: The City of Yuma's Ad Hoc Public Art Committee will identify up to three proposals for purchase. The committee will evaluate artist qualifications based on artistic merit as evidenced by submitted materials and the longevity and maintenance needs of proposed artwork. The committee and the City of Yuma reserve the right to reject any and all applications.

Application Checklist: Submit all application materials to the Yuma Art Center at 254 S. Main Street, Yuma AZ or to Arts@YumaAz.gov. Your application will not be considered valid until all items have been received. Incomplete applications will not be processed.

- AZ Transaction Privilege Tax License (TPT) or W-9 Tax Form. International artists must submit a W-8 Tax Form.
