

APPROVED → **1. SUBD-12444-2015:** This is a request by Dahl, Robbins, and Associates, Inc., on behalf of Ellington Land AZ, LLC, for approval of the Preliminary Plat for the Ellington Subdivision. This subdivision will contain 46.7 Acres and is proposed to be divided into 169 residential lots ranging in size from 6,000 square feet to 17,100 square feet. The property is located north of 12th Street between Avenue D to the west and county residences on Yavapai Lane to the east in Yuma, AZ.
