APPROVED **1. CUP-13614-2016:** This is a request by O & M Electric for a Conditional Use Permit to allow an industrial electrical contracting, in the Light Industrial (L-I) District within 600 feet of a residential zoning district. The request includes exceptions to the front yard setback and landscaping. The property is located at 983 S. 3rd Avenue, Yuma, AZ. (Continued from May 23, 2016.)
