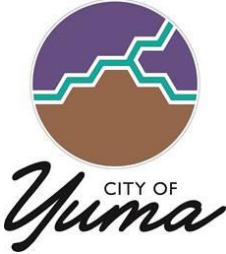


Notice of Public Hearing of the Planning & Zoning Commission of the City of Yuma

PUBLIC HEARINGS — The Planning & Zoning Commission will be considering a vote or action on the following cases. Any vote or action will be considered separately for each case. As a part of the public hearing process, the City Planning & Zoning Commission is authorized to consider appropriate alternate Zoning Districts, which are no more intensive in development activity than the requested Zoning District. Additionally, the Commission is authorized to supplement requested rezoning actions with the Aesthetic Overlay (AO) District and/or the Public Designation (P) District as may be deemed appropriate.

1. **CUP-19366-2017:** This is a request by Larson Associates Architects, Inc., on behalf of Johnson Properties, Inc., for a Conditional Use Permit to allow a drive-through for a car wash in the General Commercial (B-2) District. The property is located at 328 E. 16th Street, Yuma, AZ.

2. **CUP-19375-2017:** This is a request by Xiomara Bojorquez, on behalf of Kurt Whitney, for a Conditional Use Permit to allow a kennel, Yuma Pet Hotel and Resort, in the Light Industrial (L-I) District. The property is located at 1161 East 21st Street, Suite A, Yuma, AZ.

3. **CUP-19402-2017:** This is a request by Kimley-Horn, on behalf of Golden Arches Limited Partnership (Kareware), for an amendment to an existing Conditional Use Permit (CU95-12) to allow the addition of a secondary drive-through lane at the site of an existing fast food restaurant in the General Commercial (B-2) District. The property is located at 1610 S. Avenue B, Yuma, Arizona.

4. **CUP-19415-2017:** This is a request by JPJ Partnership, on behalf of Dahl, Robins and Associates, for a Conditional Use Permit to allow the replacement and addition of 16 new vacuum station parking stalls at the site of a legal non-conforming drive-through car wash in the General Commercial (B-2) District. The property is located at 900 S. 4th Avenue, Yuma, Arizona.
